1. My name is Michele Smith of Secretary.

- 2. I am the Party Secretary of the New Zealand Loyal (NZ Loyal) political party Ammundsen, JP #16037
 and am registered under Part 4 of the Electoral Act 1993 (the Act). PARAPARAUMU
 Justice of the Peace for New Zealand
- 3. On 29 August at 10:08am I attended a 13-minute 24-second telephone training call with Benjamin Baker for party secretaries regarding how to upload documents and submit nominations into Electoral Commission's (EC) online portal. The training call only provided me with the following information:
 - 3.1 I received the Party Secretary Nominations Manual (the Manual),
 [MS-1 Party Secretary Nominations Manual].
 - 3.2 The call merely dealt with technical aspects of the EC portal and made no mention or explanation of the New Zealand electoral system, in particular the important distinction between party list and electoral candidates and most importantly, its significance.
 - 3.3 The call felt rushed, and it was hard to understand what was being discussed without having access to the party portal or the nominations portal.
- 4. I understood the process for submitting party list candidates and bulk nominations to be: [MS-1]
 - 4.1 Page 9 step 3 of the Manual states "For a candidate contesting both an electorate and the party list you only need to enter their details once. Make sure that you select the electorate they are contesting and enter their list number".
 - 4.2 Page 9 step 3 of the Manual also states "If the candidate is Electorate Only. Remember to select the electorate they are contesting. Leave the "list number" field blank."
- Between 4 and 6 September 2023 I experienced significant delay and difficulties due to the EC portal for NZ Loyal not having been set up properly.

- 6. On 4 September at 11.44am I rang EC's Help Desk regarding issues with getting access to the party portal and nominations portal. The call lasted 16mins and 22secs and I discovered NZ Loyal's portal was not working.
- 7. I contacted EC multiple times to resolve the issue of gaining access. No one at EC knew why the portal was not working. Eventually, EC had to delete the portal and create it again. When the portal was finally working, the EC did not provide me with log in details and I had to follow up again. When I did finally get access to the portal and login details, I discovered it had still not been set up properly as the option to choose NZ Loyal as a party was missing, so I had to follow up with them about this as well.
- 8. Over the course of contact with EC, I had discussions with many different people via the Help Desk managers, including Hayden, Ravi, Jonathan, Braedyn, Sarah. These were the times and dates I rang EC Help Desk:
 - 8.1 On 4 September at 3.30pm from unknown,
 - 8.2 On 5 September at 10.46am call lasted 2 minutes and 39 seconds,
 - 8.3 On 5 September 10.51am call with Benjamin Baker lasted 1 minute and 0 seconds,
 - 8.4 On 5 September 12.41pm from (unknown caller, likely to be Adam
 - 8.5 On 5 September 12.32pm from missed call from EC, rang back but no reply, and
 - 8.6 On 5 September 2.04pm call lasted 2 mins and 36 seconds and I found out that the party portal was not working for me.
- Additionally, I had email correspondence with EC regarding issues with the portal:
 - 9.1 On 4 September at 12.07pm email to Service Desk [MS-2],
 - 9.2 On 4 September at 12.16pm email from Hayden at EC [MS-3],
 - 9.3 On 5 September at 11.54am email to Banjamin Baker, Adam

 James and Dean Shirley regarding 'Access to Party

 Portal and Nominations needed Urgently!' [MS-4],

- 9.4 On 5 September at 4.58am email to Service Desk [MS-5],
- 9.5 On 5 September email correspondence with Adam regarding 'Access to Party Portal and Nominations Sections' [MS-6],
- 9.6 From 5 to 6 September email correspondence with Adam regarding 'Candidate nominations access and manual'. The menu dropdown did not have NZ Loyal as an option in the candidate nomination section [MS-7], and
- 9.7 On 6 September email correspondence with Johnathan Pot and Sarah Chautilal regarding 'User has no Email, password or organisation' [MS-8].
- 10. All party secretaries were given access to these portals on Monday 28 August 2023. I was not able to properly access the portal until or about 6 September 2023, which was 9 days after other party secretaries.
- 11. During the period of 5 to 8 September I uploaded the first batch of nomination forms, which were the 9 confirmed candidates.
- During the period of 12 to 14 September I uploaded the second batch of nomination forms, which were the 28 candidates.
- 13. On 12 September 2023 Mr James from EC emailed and informed me the deadline for submission of party list candidates and bulk nominations to the EC for the 2023 General Election was 12 noon on 14 September 2023 (the Deadline). I forwarded this email to Ms Gunn and Gerrie Quinn. [MS-9 Email correspondence with James
- 14. During the period of 13 to 14 September 2023, the bulk nomination forms were uploaded in the last 48 hours prior to the 12pm close off [MS-10 Bulk Nominations].
- 15. After I uploaded the nomination forms, the online portal produced schedules for me to sign.
- 16. On 14 September 2023 I declared at Waikanae in front of the Justice of Peace the Party List Declaration, which included the list of qualified candidates and to be elected a member of Parliament both in terms of the Act and any other enactment. [MS-11 Party List Declaration].

- 17. Following the Manual guidance in sub-paragraph 4.1 above, as the electorate candidates were also list candidates, I only entered their names in the electoral schedule and not the party list schedule.
- Furthermore, following the Manual guidance in sub-paragraph 4.2 above, I submitted one PDF as the bulk nomination schedule.
- 19. I was confused by the Manual guidance on Page 9 of the Manual and entered the electoral candidates to the bulk nomination candidates in the second schedule, but not the number of their order of preference in the party list. There was no space on the form downloaded to indicate where the order of preference should be inserted. There were no notes, reminders or warnings on the form or in the nominations portal stating that the order of preference on the party list must be indicated for candidates within the bulk nomination form who were also party list candidates.
- 20. On 14 September 2023 I received an acceptance of nominations and party list letter from EC. The letter addressed the EC's acceptance of the bulk nomination schedule of electorate candidates and party list lodged for the 2023 General Election in accordance with ss 127 and 146G of the Act. Further, the letter acknowledged the payment made of a deposit of \$10,900 received on 14 September in accordance with ss 127A and 146F the Act. [MS-12 Signed Letter of Acceptance].
- 21. On 14 September 2023 at 2.04pm I emailed Benjamin Baker informing, "I would be inputting some candidates via the individual candidate nomination process as well with cut off time of midday tomorrow, Fri 15th." [MS-13 Email to Benjamin Baker]
- 22. On 14 September 2023 at 2.19pm I received an email from Benjamin Baker stating, "Parties using the bulk nomination system can't also do individual nominations. The bulk nominations system has closed." [MS-14 Email response from Benjamin Baker at 2.19pm].
- 23. On 14 September 2023 at 4.24pm I rang EC regarding withdrawing candidates and adding candidates to the party list. EC told me the Deadline was the cutoff. Further, even if somebody was to resign, we could not replace

- them. I was told we could remove people, but we could not replace them. The call lasted 4 minutes and 47 seconds.
- 24. Further, on 14 September 2023 at 8.47pm I received an email from Benjamin Baker stating, "a candidate cannot simply be added at this stage". [MS-15 Email response from Benjamin Baker at 8.47pm].
- 25. On 15 September 2023 I rang EC again and asked if EC were able to add list numbers to our electorate candidates, which were left out inadvertently. I was informed that it was too late to accept party list numbers.
- 26. The party list with the electorate candidates included is at [MS-16]. This is the final version list that the EC refused to accept.
- 27. The EC failed to assist me in the process of submitting party list candidates and bulk nominations into the EC's online portal.

Overview

This manual is for party secretaries of registered parties to provide step by step guidance for the process of nominating your candidates for the 2023 General Election.

Types of nomination

As the party secretary, you are responsible for the nomination of:

- · candidates on your party's list
- · electorate candidates standing on behalf of your party if you are using the bulk nomination process

Parties that use the bulk nomination process nominate all their electorate candidates on a schedule that is lodged with the Commission.

If a party secretary does not use the bulk nomination process, your electorate candidates must use the individual nomination process, where two electors registered in the electorate being contested nominate the candidate and the candidate is responsible for lodging the nomination paperwork.

What information do I need to nominate candidates?

The manual provides an overview of the information you need to collect from candidates, and steps you need to complete to nominate your candidates.

You need to be satisfied your selected candidates are eligible to stand at the election. To have their nomination accepted, a candidate must be:

- a New Zealand citizen
- enrolled to vote

It isn't a legal requirement that documentary proof of citizenship be provided by candidates. However, it is the Commission's policy to request that candidates born overseas provide proof of their citizenship status to ensure only eligible candidates are included on the ballot papers and party lists. Evidence of citizenship can be a copy of their New Zealand passport or New Zealand citizenship certificate. It doesn't have to be a certified copy. Where this evidence can't be provided we will have to ask the candidate to complete a form to allow us to verify citizenship with the Department of Internal Affairs.

We recommend you check your candidates are enrolled, using the printed rolls or roll data you can purchase from the Commission (email data@elections.govt.nz), or ask your candidates to confirm their enrolment details are up-to-date. Electors, other than anyone on the unpublished roll, can check their own enrolment details at vote.nz. Candidates on the unpublished roll will have recently received written confirmation of their enrolment details by post as part of the enrolment update campaign for the election. If a candidate needs to update their details, because they've recently moved, or because they are not enrolled, it is important this is done as soon as possible. More information about enrolling or updating enrolment details is available at vote.nz. You need to contact us urgently if any of your candidates need to enrol or update their details after writ day (10 September).

Candidates on the party list, or bulk nomination schedule, or both must also complete a consent to nomination form.

We recommend you start sending us the consent forms and citizenship evidence, if required, as soon as possible after nominations open on **28 August**, and by **Friday 8 September** at latest so that there is time to remedy any issues identified. Please send this information by upload via the Party Portal or by email to

How do I compile my candidates nominations?

Generally, parties will use the online nominations system, which is a secure website that can only be accessed by authorised persons via the Party Portal to collate their party list and bulk nomination schedule. The system allows you to allocate a list number and electorate to each candidate entered into the system and generate the party list and bulk nomination schedule, which are then printed out and signed in front of a person authorised to witness a statutory declaration.

A party that is lodging a party list and using the individual nomination process for the nomination of electorate candidates will use a Word document, instead of the online system, to collate their party list. The party secretary of a component registered party will use a Word document, instead of the online system, to collate their bulk nomination schedule. We will send the Word templates, as needed, to parties that are not using the online system.

When can I access the online nomination system?

The system will be available from 9.00 am Monday 28 August to noon Thursday 14 September 2023.

Prior to nominations opening the Commission's IT team will set up a username and password for each party secretary and administrator that needs to access the nominations system. Your username and password will be sent to you by email on **28 August**.

Please note that entering details into the online nominations system **does not** constitute lodgement of your bulk nomination schedule or party list, these will need to be lodged with the Commission by upload via the Party Portal, email, or in person.

We advise that your bulk nomination schedule and party list sh	rould be lodged as soon as possible
from 28 August via the Party Portal, by email to	or in person at our offices in
Wellington, However, they cannot be formally accepted until a	fter writ day, 10 September.

All candidates are registered as electors and there is no reason why any candidate is not eligible to stand for Parliament (see section 80 of the Electoral Act 1993 for who isn't eligible to enrol)
Collating your party list - checklist
You have allocated a list ranking to each list candidate
The list rankings are consecutive, 1,2,3 etc with no gaps or double ups
You have entered the residential address (or 'UNPUBLISHED' for any candidates who are on the unpublished roll) and a contact phone number for each candidate on the party list
Collating your bulk nomination schedule - checklist
You have allocated the correct electorate to each electorate candidate
You have no double ups of two candidates standing for the same electorate
You have entered the candidate's full name as provided on the consent form (step 4) onto the bulk nomination schedule

Organise the nomination deposit and witnessing of declarations



Accessing the Online Nominations System

Accessing the system

Step 1. Log into the Party Portal

Click on the login button on the ribbon at the bottom of the elections.nz website.



Please refer to the Party Portal login instructions for more information about setting up multifactor authentication to access the Portal.

Contact the Service Desk (see contact details on page 3 of this manual) if you need help logging into the Portal.

Step 2. Click on NOMINATIONS OPEN link on the homepage of the Party Portal

You will then be directed to the login page to access the online nominations system.



Logging in

This is your login screen. Enter your username and password sent to you by email and click Login.



When you first log in you will be prompted to change your password to one that you choose.

Your chosen password must follow general password guidelines:

- · Must be at least 8 characters in length
- Must contain at least 3 of the following.
 - Uppercase letter
 - · Lowercase letter
 - Numeral
 - · Special character

Keep the new password safe. Do not share your password. If written down, keep in a secure location. If you forget your username or password please contact the Service Desk.

For security reasons, if you enter the wrong password three times in a row, your account will be locked. Please contact the Service Desk if this occurs so that we can arrange for your account to be unlocked.



Entering Candidates

Adding a new candidate

Step 1. Click on Candidate Maintenance from your home screen



Step 2. Click Add on the right-hand side of the screen



Step 3. Enter in the candidate's details

For a candidate contesting both an electorate and the party list you only need to enter their details once. Make sure that you select the electorate they are contesting **and** enter their list number.

Note: The system will notify you if you add two candidates for the same electorate or same list preference

If the candidate is Electorate Only

- · Remember to select the electorate they are contesting
- · Leave the 'list number' field blank


Note: Electorate only candidates will only be included in the bulk nomination schedule and not in the party list

If the candidate is List Only

- Leave the 'electorate contesting' field blank
- · Remember to enter a list number

Note: List only candidates will only be included in the party list and not in the bulk nomination schedule

Step 4. Review the candidate details entered and click Save after you enter each candidate

Producing and printing the Bulk Nomination Schedule

Checksum

Above the bulk nomination schedule and the party list is a series of upper and lower case letters called the "checksum". The checksum shown on the bulk nomination schedule will be different to the checksum shown on the party list.

The checksum is used to ensure that the candidate details that appear on the printed versions of the bulk nomination schedule and party list are exactly the same as what has been entered into the nominations system. Any changes made to candidate details, no matter how small, will change the checksum.


Make sure your final printed bulk nomination schedule and party list match the checksums in the online system. We recommend you reprint the form if the checksum has changed. If the checksums do not match, the Commission will work with you to identify and correct the discrepancy (time permitting).

Producing the Bulk Nomination Schedule

Step 1. In Candidate Maintenance, click the Candidate Nominations button



- Step 2. Review the candidate entries. Please check that:
 - · All electorate candidates have been entered
 - All electorate candidate details are correct and match what each candidate has specified on their consent to nomination form
 - Each electorate being contested has no more than one candidate entered
- **Step 3.** Print the declaration, fill in the remaining details and sign it before a person authorised to take statutory declarations







Producing the Party List

Step 1. In Candidate Nominations, click List Nominations



- Step 2. Review the candidate entries. Please check that:
 - All list candidates have been entered
 - All list candidate details are correct and match what each candidate has specified on their consent to nomination form
 - The list candidates are in the correct order
 - · There are no duplicates in the list number preferences allocated
- **Step 3.** Print the declaration, fill in the remaining details, check any component parties are correctly listed and sign it before a person authorised to take statutory declarations

As I'm sure you'll be aware, we are approaching the final cut off date for bulk nominations of electorate candidates and submission of party lists.

This means that we need to have resolved any and all issues, and received JP witnessed copies of the bulk nomination schedule and party list, preferably by end of day tomorrow (Wednesday) so that we can check these before the legal cut-off of noon on Thursday 14/09/2023.

As things currently stand, we have 9 NZLOYAL candidates entered into EMS. Finally, and most importantly I notice that as of the morning of 12/9/23 there are 17 candidates listed on the NZLOYAL website. 

While a candidate cannot simply be added at this stage, if a candidate wanting to withdraw is electorate only, there is provision for the candidate to withdraw their nomination under section 146J of the Electoral Act. To do you will need to complete this form (attached) and have it witnessed and submit it before noon tomorrow (15 September).

If a candidate is withdrawing, then there is provision for a new candidate to be added to replace that candidate (section 146K). The same rules apply, you will need to submit a schedule that is witnessed, a copy of a consent form from the new candidate, and instructions on whether the fee paid for the withdrawing candidate is to be applied to the new candidate.

Rather than redo the whole bulk nomination, I would suggest that you could just add the substitute candidate by completing the following schedule just for the one candidate. Note that this is only an option if the added candidate is put into the same electorate that the person is withdrawing from. Again it must be witnessed and provided before noon tomorrow.

Hope that makes sense.
